## REQUEST FOR PERMISSION TO PUBLISH MANUSCRIPT MATERIALS

1. The undersigned hereby requests permission to publish specific manuscript materials physically owned by the Casper College Foundation or Casper College Western History Center.
2. Permission to examine manuscripts in the Casper College Western History Center is **not** an authorization to publish them. To the extent that it may properly do so, the Western History Center will ordinarily grant publication rights to qualified applicants. Scholars who plan eventual publication of their work are urged to inquire concerning overall restrictions on publications **before** beginning their research.
3. Authorization to publish is not exclusive and the Casper College Western History Center does not thereby surrender its own right to publish or grant others permission to do so.
4. If permission to publish is granted, the location of the cited manuscripts shall be indicated in the published work. A dissertation is considered to be a published work. Credit should be given as follows: Title of Collection. Casper College Western History Center
5. I understand that the copyright law of the United States (Title 17, United States Code) governs the unauthorized publication of previously unpublished materials. *It is not my intention to publish or otherwise reproduce any materials which are possibly subject to copyright without first having obtained written permission (a) from the copyright owner, his heirs or assigns, and (b) the Casper College Western History Center or Casper College Foundation, owner of the original materials.*

*This institution reserves the right to refuse permission to publish manuscript materials if, in its judgment, publication would involve the violation of copyright law or would infringe upon literary rights.*

6. Web publication is **not** allowed without separate written permission.
7. Prints, photocopies and/or electronic files may **not** be published electronically, rescanned for other uses, or distributed to others without separate written permission.
8. Prints, photocopies and/or electronic files may **not** be added to the collections of, or transferred to, other researchers, scholars or repositories (including other archives, libraries or museums) without separate written permission.
