Articulation Agreement Between Olds College and Casper College



This articulation agreement is effective July 1, 2012 and is established to provide the opportunity for graduates of the Agriculture program at Casper College to gain entrance into the two-year Bachelor of Applied Sciences Degree in Agribusiness at Olds College.

Objectives of the Agreement

- 1) To provide diploma graduates from Casper College who satisfy the criteria identified by Olds College and described in this agreement, the opportunity to obtain admission to the Bachelor of Applied Sciences Degree in Agribusiness at Olds College.
- 2) To attract qualified students to Casper College and Olds College.
- 3) To provide specific program and course information to Casper College Degree graduates who wish to pursue an applied science degree.
- 4) To establish the processes to encourage, review and expand, if appropriate, the articulation agreement between Casper College and Olds College.

Terms of the Agreement

- 1) In a manner consistent with its admission requirements, policies and procedures, Olds College will grant admission to its 60 credit hours (30 credit hours for 10 academic courses, 30 credit hours for an eight month Directed Field Studies program), two-year Bachelor of Applied Sciences Degree in Agribusiness to qualified graduates of the A.S. in Agriculture, A.S. in Agri-Business, A.S. Animals Science, A.S. Range Management, A.A.S in Agri-Business, A.A.S. Animal Science Technology Degrees at Casper College who have achieved a minimum cumulative grade point average of 2.5 (on the four point grading system) in the above mentioned degree programs as described on pages 41-44 of the 2011-2012 Casper College course catalog. - 2) Both Casper College and Olds College will cooperate in promoting the Bachelor of Applied Sciences Degree in Agribusiness to qualified Casper College graduates and agree to provide information and assistance to prospective transfer students.
- 3) This articulation agreement will become effective July 1, 2012 and shall have a term of five years, automatically renewable thereafter.

- 4) Termination of this agreement shall only be undertaken by either party with written notice of at least one calendar year (12 months). In the event of termination of this agreement, all students enrolled in the Casper College Associate's Degree program at the date of such termination shall be entitled to admission to the applicable Olds College (as outlined above) upon graduation so as to ensure the fulfillment of the reasonable expectations of such students.
- 5) Either institution must inform the other if substantive changes in curriculum (greater than 15%) are to be implemented.
- 6) Both Casper College and Olds College will designate a Program Representative in their respective institutions to facilitate coordination of this agreement.
