2 + 1 + 2 Casper College Transfer Agreement

Associate Degree in Athletic Training + Allied Health Science/Master of Athletic Training

Introduction

This proposal describes a new program for two-year athletic training associate degree graduates to complete a Bachelor of Arts in Allied Health Science (AHS) and a Master of Arts in Athletic Training.

Rationale and Justification

We are entering a new era in education. Student acquisition and retention is becoming our top priority. We must formulate strategies to address the decrease in the prospective student population.

Carthage has offered transfer degree opportunities for more than two decades. This transfer agreement is the reverse of the Carthage tradition. The students will enter Carthage after partially completing our AHS major requirements and finishing the bachelor's and master's degrees at Carthage.

This program is a mutually beneficial collaboration with Casper College. The goal is to strengthen the size and diversity of the Carthage Allied Health Science and Athletic Training student population and enhance options for continuing the education of Casper College graduates.

Casper College offers an associate degree in Athletic Training. An average of ten students are enrolled in the program. Casper graduates must move into undergraduate and graduate level programs to afford the student the ability to sit for the Board of Certification exam.

Program Framework

The Casper College athletic training associate degree is 66 credits combining athletic trainingspecific courses with social science, humanities, oral and written communication, fine arts, wellness, and statistics. The student will transfer 66 credits entering the junior year as an Allied Health Science major. The associate degree will serve as a completion for all Carthage General Education requirements. Direct admission to the Carthage College Master of Athletic Training Program for Casper College transfer students requires a 3.0/4.0 GPA. They will complete the remaining AHS courses during their junior year.

Students will use the traditional full-time UG financial aid model for their junior and senior years. The 5th year cost is \$28,000. They could take the \$20,500 Graduate Stafford Loan and cover the remaining \$7500 with a Graduate Plus Loan.
